- 8. Dante went to the house and saw some water damage. Spring clean up need plywood bolstered and window coverings. Also, John observed raccoons in the kitchen roof. We need to call an exterminator
- 9. Consider direct mail and email campaigns to increase membership. Plan to build a nest egg as we get ourselves ready for applying for grants in 2021.
- 10. We work on getting historic designation and Chris will work on contacts with other Van Riper descendants
- 11. Dante: The Anarchist's Guide to Historic House Museums want all the officers to read it and watch a video by one of its authors. Difficult for places similar to Kingsland Manor to maintain relevance, this book as good information for funding and repurposing a historic home
